ORDER:-

In the Government Order read above, Government have issued orders revising the rental tariff for State Guest House, Chepauk, Chennai-5; Government Rest House, Chintadripet, Chennai-2 and New State Guest House, Omandhurar Government Estate, Chennai.

- 2. Now, the Government have decided to revise the rental charges for State Guest House, Chepauk, Chennai-5; Government Rest House, Chintadripet, Chennai-2 and New State Guest House, Omandhurar Government Estate, Chennai, as suggested by the Finance Department.
- 3. Accordingly, the revised rental tariff for State Guest House, Chepauk; New State Guest House, Chennai and Government Rest House, Chintadripet, Chennai-2 are mentioned below and direct that the following rates shall come into force with effect from 01.04.2023.

Note:

- (a) Official visit: Officers arriving in Chennai on Invitation / on duty for meeting /conference /discussions/ Training and officials who are appearing before Hon'ble High Court / District Court/Various Commissions /Tribunals are considered on official visits. Relevant Government Order/ Letter of Invitation / Letter of conference /meeting / Court summons /Training to be submitted along with online application, in the absence of which, it will be considered as private.
- (b) **Private visit:** Any official guest visiting Chennai on any other capacity other than mentioned in para 3 (a).
- (c) <u>Family Members:</u> Family members includes wife and children including an adopted and step –Children of the Officer, who are dependant on the Officer.
- (d) For every reservation, a maximum of only two rooms for 5 days can be made.
- (e) From 6th day to 15th day, the tariff will be doubled and from 16th day to 30th day, the tariff will be tripled as detailed in the annexure.
- (f) Those staff accompanying officers on official duty will be charged category-I tariff.
- (g) Officers reserving or availing rooms for duration less than a day will be charged Rs.250/- as cleaning & service charges.
- (h) No stay will be extended beyond 30 days, unless specific order are obtained from Government.
- (i) Additional Beds per room will be charged Rs.100/- per day
- (j) The dignitaries / beneficiaries such as cultural delegation / Awardees/other individuals specially invited by the Government for any particular Government function will be charged Category –I tariff.

- (k) For Guests of All India Service Officers of Tamil Nadu Cadre / Retired AIS Officers from Tamil Nadu Cadre, the private tariff of category-I will be charged.
- 4. In modification of earlier order, for the 'Category-I & II the revision of rates will be done when the need arises, based on the orders of Government and G.O.(Ms) No.490, Public (Protocol-II) Department, dated:13.07.2018, an annual increase of the category III by 5% may be done annually with effect from 1st April of every year.
